International Homeopathy Day 2013

LMHI promotes homeopathy in Bogotá, Colombia

The International Homeopathy Day (IHD) 2013 was celebrated with an International Symposium on “Homeopathy in the 21st Century” in Bogotá, Colombia, on 13 April 2013. The conference was organized by the LMHI member association “Fundación Instituto Colombiano de Homeopatía Luis G. Páez”, a university college foundation of homeopathic medicine that looks back on more than one hundred years of tradition and has trained generations of homeopathic physicians and veterinarians. The academic symposium dealt with theoretical and practical aspects of clinical homeopathy and took place in the presence of National Government delegates, Health Authorities, and representatives from Colombia’s Medical Education Associations and Homeopathic Medical Schools, such as FUNHOM, ASCOHOM, AMHUS, Institute Dr. Juan de Dios Hahnemannian Pinzon, and Fundación Universitaria Juan N. Corpas. The LMHI was represented by its President Dr José Matuk Kanan (Mexico) who spoke about the “Homeopathic Principles of the LMHI” and by Dr Edgar Godoy, LMHI Secretary for Archives (Ecu-

Dear Friends,

Matuk highlighted in his remarks that “the fusion of different organizations for this ‘World Day of Homeopathy’ has demonstrated the binding commitment of homeopathic physicians in Colombia.” The ceremony was broadcast in the media and Colombia’s President Juan Manuel Santos supported the IHD celebration, which culminated with a music presentation and a wine reception, by sending a message of greeting.

Developing and Securing Homeopathy Worldwide

The LMHI International Homeopathy Day (IHD) takes place every year on the occasion of Samuel Hahnemann’s birthday on 10 April 1755 to promote homeopathy in the public awareness. It was initiated by the LMHI in association with the European Committee for Homeopathy (ECH) and held for the first time in Slovenia (2010), followed by Croatia (2011), and Turkey (2012). The personal presence of executive LMHI representatives and their political support have proven an important tool in gaining respect from the national governments. “In these projects, the LMHI fulfils its purpose of developing and securing homeopathy worldwide – as stipulated in its *Statutes*”.

High-ranking Germany officials, among them the Secretary of State in the Ministry of Science and Economic Affairs of Saxony-Anhalt and Köthen’s Lord Mayor Kurt-Jürgen Zander, and more than 50 guests from all around the world, including India, Bangladesh, Japan, Turkey, and Serbia, as well as from Belgium, Austria and the Netherlands, attended the ceremonial event on 16 March 2013 that was hosted by the LMHI.

Lord Mayor Zander proudly characterized Köthen as “homeopathic hub” and emphasized that “Köthen is proud and honoured to be, from now on, the statutory seat of the LMHI”. Köthen once provided Samuel Hahnemann with the freedom to develop his doctrine. The city’s particular affiliation with homeopathy was reinforced in 2010 when Köthen took part in the International Building Exhibition on “Urban Redevelopment” and the guiding principles of homeopathy were successfully applied to town planning for the very first time.

Homeopathy under attack I

United States: Lawsuits against homeopathic products

Homeopathic medicines are protected as legal drugs under the Food, Drug, and Cosmetic Act (FD&C) at the federal level in the United States. However, the attempt to eliminate them is coming at the state level. Unlike conventional drugs, homeopathic medicines do not have to undergo the Food and Drug Administration’s new drug approval process. Pre-market authorization for homeopathic medicines comes from the *Homeopathic Pharmacopoeia of the United States (HPUS)* monograph, which involves clinical verification of the efficacy of the substance. Despite federal law, however, the presence of an *HPUS* monograph has not protected homeopathic products from several lawsuits filed under California’s consumer protection law. This is creating an environment of uncertainty and could threaten the marketing of these products in California and other states.

In 2012, the U.S. District Court, Southern District of California, approved a settlement agreement in a class action lawsuit against Boiron Inc. The agreement has provided \$5 million in refunds to consumers who purchased certain homeopathic products, including Oscillo, Arnicare, Chestal and Coldcalm. Boiron also agreed to change its labeling and add a disclaimer, as well as provide additional information on homeopathic dilution to its customers. The suit “Gallucci v. Boiron” alleged the world’s leading homeopathic manufacturer made false claims regarding more than twenty-four homeopathic products, that they could effectively

treat ailments such as the flu, arthritis, sore joints, joint pain, aches, fever, coughs, insomnia or sleeplessness. Ignoring the principles of homeopathy, the plaintiffs also argued that Boiron’s products are so diluted that they are “effectively nonexistent” and are thus like placebo or sugar pills. “This is similar to saying that because homeopathic preparations are not like standard drugs, they are fraudulent – exactly the kind of claim that federal protection under the FD&C Act was designed to prevent”, critics of the settlement argue. Two other class actions in California were filed against Hyland’s and Standard Homeopathy, alleging the companies marketed their homeopathic products as having health benefits while knowing the products had no active ingredients in amount sufficient enough to cause any beneficial actions. The suits also accuse the defendants of violating the Consumer Legal Remedies Act, the Unfair Competition Law and the Unfair Advertising Law, as well as breach of express warranty, implied warranty of merchantability, and money had and received, money paid and unjust enrichment. The companies successfully won dismissal of the unjust enrichment charge, but the others were kept up. According to the American Association of Homeopathic Pharmacists (AAHP) cases like these are unlikely to damage the reputation and viability of the homeopathic industry, and settling such lawsuits does not give allegations such as “no active ingredients to deliver benefits” any weight or credence.

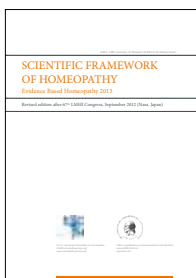
Brazil: “Media Circus” about homeopathy

Brazilian homeopaths have to deal, once again, with an attack from the media. On 30 April 2013, the popular magazine *Revista Época* published a full-page article titled “The Madness of Homeopaths” (A loucura dos homeopatas) by Walcyrr Carrasco, a journalist and author of popular books, plays and television soap operas, in which he called homeopaths “irresponsible” and even “lunatics” because of their position against mass vaccination. Homeopathy, Carrasco concluded, is not a science. Dr Francisco Vilella,

President of the Brazilian Medical Homeopathic Association (AMHB) and the LMHI’s National Vice-President (NVP) for Brazil, and Dr Geraldo Ribeiro Brown, LMHI Secretary for Dentistry are now working with the LMHI on strategies how to react to such popular press attacks. Sara Eames, NVP for the UK and head of the LMHI Public Relations Team, emphasized that evidenced-based argument is the best way to deal with such “media circus”.

LMHI Research Publications

Scientific Framework of Homeopathy - Evidenced Based Homeopathy 2013



The revised edition incorporates the update information after the 67th LMHI Congress in September 2012 in Nara, Japan. The joint publication of LMHI and ECH (European Committee for Homeopathy) is aimed at considering all important aspects of the scientific framework of homeopathic practice including ethical questions, evaluation of daily practice and looks

at the level of scientific evidence of each of these aspects. The important conclusion is that homeopathy has to stay in the framework of medical practice and is a necessity for public health and therefore calls for more research.

The importance of clinical verification of homeopathic is historical but even more important to validate “modern” homeopathic practice, the similarity law and the individualization rule including a global view on the patient. An unconfirmed proving symptom that never was verified by clinical data cannot yet be considered as useful for homeopathic practice. We want to stress that this kind of research is meant first to improve homeopathy. Our proposal aims to gather data without interfering with daily practice accepting a lack of control mechanisms. Participants in this research should realize that biased observation has a negative influence on the quality of the data.

Second edition of LMHI Guidelines for a Homeopathic Drug Proving



Homeopathic drug proving is essential in the development of the homeopathic art of cure. After clinical verification of the collected symptoms, it provides a necessary tool to find the most appropriate remedy for the patient. Many theories, methods and protocols have been established. Meanwhile ethical and legal requirements have become more and more

important (Declaration of Helsinki, ICH Guidelines January 1997). A homeopathic drug proving (HDP) is nowadays considered to be a clinical trial, as such these Guidelines are based on the ICH “Note for Guidance on Good Clinical Practice” (CPMP/ICH/135/95). Guidelines are not strict rules but will ensure that all relevant items necessary for a homeopathic proving respecting Good Clinical Practice (GCP) are taken into account. It will help also to obtain comparable results from provings of a same medicine in different places in the world.

Third edition of LMHI Guidelines on Clinical Verification of Homeopathic Symptoms

Systematic clinical data collection must match contemporary reality as a whole. The aim of these guidelines is to promote convergence in the publications on verification of homeopathic symptoms. The proposed data collection system has to be flexible and accessible manually or by information technology. The ultimate objective of this proposal is to use an automatic information system allowing collection, recording, extraction, processing, interpretation, evaluation and communication. This system must allow verification of symptoms from remedy provings as well as clinical symptoms, which will never originate from pathogenetic trials. Clinical data collection and classification systems must respect the ‘essence’ of homeopathic practice, the law of similars.

8th annual ICCMR Congress: New results of research on homeopathic medicines

Can water possibly have a memory?

Report by LMHI Secretary for Research, Dr Michel van Wassenhoven

Homeopathic medicines are currently used in medical practice, despite controversy about their effectiveness. The preparation method is based on extremely high dilutions of many substances in water, far beyond any detectable level. For this reason, it has been suggested that water could retain a 'memory' of substances that have been dissolved in it before the successive dilutions. As early as in 2007, Joao Teixeira and his colleagues stressed the fact that this idea is not compatible with our knowledge of pure water. The researchers concluded: "If an explanation on physical grounds is to be found, research must focus in other aspects of the preparation, such as the presence of other molecules and dissolved gases." Teixeira and col-

leagues published their study under the title "Can water possibly have a memory? A sceptical view". His idea has been followed by Prof. Montanier in 2009. Based on his research results, he hypothesized that the nature of this "material" can only be found at a nanolevel.

Homeopathy is emerging as nanomedicine

In April 2013, this hypothesis was discussed at the 8th International Congress of Complementary Medicine Research (ICCMR 2013) in London and begins to be confirmed by other independent research teams. Homeopathy is emerging as nanomedicine. Due to the dynamization process during the manufacturing of homeopathic medicines the final product contains nanoparticles and conglomerates of them. After a first phase of homeopathic stock dilution they are simply transferred from one dilution to the other without further relevant dilution. These nanoparticles are stabilized by silicon and other elements. This breakthrough is important for the future of homeopathy; it can explain all previous laboratory results and is able to avoid *a priori* criticism due to a plausibility bias that "there is nothing in these medicines".

Further research is always needed, but we have now a sound thesis, and a very promising hypothesis that needs more confirmation.

Reminder Online Survey

Homeopathic Pharmacy and Dentistry in the World

As reported in the December 2012 issue of the *Liga News*, LMHI Secretary for Pharmacy Fruzsina Gábor and LMHI Secretary for Dentistry Dr Geraldo A. Brown Ribeiro started an online-survey last year about the status of homeopathic pharmacists and dentists and the situation of homeopathic remedies in different countries: Are there basic introductory courses and postgraduate courses in homeopathy and/or homeopathic pharmacy in your country? Are pharmacists allowed to dispense homeopathic remedies without any prescription and to consult with the patients? Are there homeopathic laboratories in your country and do they produce/prepare locally? Are classical homeopathic remedies available in pharmacies or in others places instead of pharmacies? How many homeopathic dentists are working in your country and is there an association representing homeopathic dentists? Are there any specific courses in homeopathy for dentists and is homeopathy

included in the curriculum of the Dentistry University? Not all of the LMHI's member countries have responded, yet.

Please support our work in the LMHI! The more information from experts is available, the better we can help each other to be much more effective in our homeopathic society! More answers and input are needed to complete the survey in the three relevant fields and to cover as many countries and as many questions as possible. LMHI Accreditation of Homeopathic Teaching Centres

Turkish Classical Homeopathy Association becomes first LMHI accredited school
